

## Transition requirements for the new Construction product regulations

**NF48** 

The new construction products regulation (EU) 2024/3110 was published on the 18 December 2024 and this will replace the existing construction product regulation (EU) 305/2011.

Background: The new CPR entered into force on 7 January 2025 and regulation will start to apply on 8 January 2026. Certification bodies that are active in this technical area should put in place a plan for accreditation to the new construction products regulation and apply for extension to scope through the CRM. Please follow INAB guidelines for extensions to scopes and allow a six-month time frame.

## Accredited certification bodies are required to:

- Plan and prepare to apply to INAB for transition with an extension to scope application.
- Complete a gap analysis identifying the changes between new and old regulation and how the CB will be address the new regulations.
- Review processes and procedures affected. This can include sales/quoting, the auditing/evaluation process, competence management and communication with existing certified clients.
- Analyse impact of changes on relevant activities/processes and identify required actions to ensure conformance (e.g., management system/documents, IT tools).
- Implement required actions including a timely communication to the clients on the transition programme, such as the timeline, transition audit approach, and the consequences if the client fails to transition prior to the end of the transition period etc.
- Ensure that relevant personnel affected by the changes are competent for the revised regulation. Personnel may include, but not be limited to, auditor, reviewers of audit report, certification decision maker, contract reviewer, and planner.

**NOTE:** CABs are encouraged to plan and commence required actions at the earliest opportunity.

CABs should submit evidence of the above with the application for extension to scope six months in advance of assessment. INAB will either conduct a technical review at the CAB's head office to coincide with head office surveillance or as a separate assessment event in 2026. A witnessed audit will be required. A minimum of 0.5 assessment day to confirm transition will be required.

## **Key Timescale**

July 2025: Extension to scope to be submitted to INAB for assessment in 2026.

**January 7, 2025:** The revised CPR entered into force.

NF48 Transition requirements for the new construction product regulations *Issue 1 May 2025* Page 1 of 2 January 8, 2026: Harmonized standards incorporating initial environmental requirements, particularly related to climate change effects, become applicable.

In the first year after a harmonised technical specification is made mandatory, manufacturers can choose to follow either the new standard or the old one. This coexistence period may be extended in some cases if specified in the implementing act.

July 7, 2026: Manufacturers are required to comply with the Digital Product Passport system.

January 9, 2030, and January 9, 2032: Additional environmental requirements will come into effect on these dates.

EADs listed in the Official Journal by 8 January 2026 will be referring to the old CPR, and they remain valid until 9 January 2031, unless they expire sooner.

Products based on European Technical Assessments (ETAs) issued under these EADs can continue to be sold for up to 10 years from the application date, in 2036.

January 9, 2039: Complete withdrawal of the previous regulation, Regulation (EU) 305/2011.
